


Article Seven - Incorporator

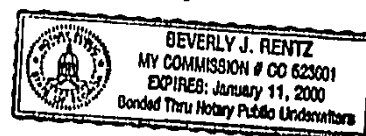


