

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I – NAME

The name of the corporation shall be ADJUNINA, INC.

1. The general nature of the business of the corporation shall be operating a retail store and any other lawful business.
