Enclosed is the application for reinstatement along with a check for \$308.75 which includes the 1998 fee of \$150 and the 1999 fee of \$150 plus a certificate of good standing for \$8.75.

We would like to state that the original application that was mailed at the beginning of 1998 was never received by us because we moved from the original address (1141 S.W. 84 ct. Miami, Florida 33144) and even though we left a forwarding address, it was never sent to us to our new address. After that we moved to our present office address of 14645 S.W. 42 st. Miami, Florida 33175.

Our business is small and has not had any commercial activity since it was created. We are starting as of this month and charging us a reinstatement fee of \$550 would be a burden to us. Therefore we request that you abate the reinstatement fee and accept the above check to reinstate us in good standing. We formed the corporation in July 1997 and unfortunately we do not remember our legal advisor telling us that we would have to pay an annual fee to keep the corporation active. Now we know and can assure you that this incident will not happen again and in the future we will inquire if we do not receive an annual renewal form at the beginning of each year.
