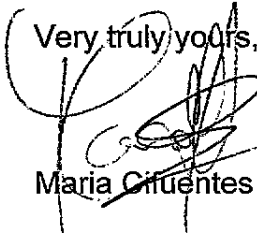

**SECOND**

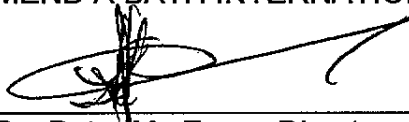
The amendment to the Articles of Incorporation was adopted on February 24, 1998.
