ARTICLES OF INCORPORATION OF TRAVEL AGENTS SERVICE NETWORK, INC.

ARTICLE I. - Name

The name and address of this corporation is Travel Agents Service Network, Inc.,
27 Broadway, Kissimmee, Fl. 34741.

ARTICLE II. - Duration

This corporation shall exist in perpetuity, commencing on July 3, 1997.

ARTICLE III. - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV. - Capital Stock

This corporation is authorized to issue 10,000 Shares of \$1.00 par value common stock.

ARTICLE V. - Pre-emptive Rights

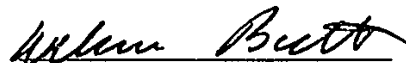
ARTICLE IX. - By-Laws.

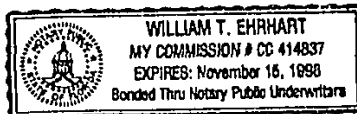

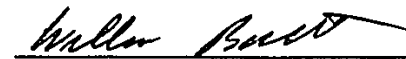
