**ARTICLES OF INCORPORATION OF
BIBLE MOTIVATION INSTITUTE, INC.**

ARTICLE I. - Name

The name and address of this corporation is Bible Motivation Institute, Inc.,
27 Broadway, Kissimmee, Fl. 34741.

ARTICLE II. - Duration

This corporation shall exist in perpetuity, commencing on July 3, 1997.

ARTICLE III. - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

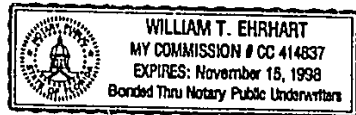


