
As per our conversation today I am enclosing the following on behalf of Griffis Timber, Inc and Willie Griffis Timber, Inc.

Each of these corporations is inactive effective October 16, 1998 for failure to file the required annual reports. As I indicated in our conversation, the Griffis' are involved in an on-going investigation by the Florida Department of Law Enforcement and the Statewide Prosecutors office. This investigation centers on a former bookkeeper. He was employed by the Griffis' to manage each of these businesses. Consequently, a large amount of records have been removed from their office. In addition, there has been a tremendous strain on the Griffis' both financially as well as emotional. During the course of this investigation many things have not been completed due to the lost of records. We are not sure if the annual reports were ever received or if they went to the former bookkeeper.

We have completed the application for reinstatement. In addition, we have enclosed a check for \$300 payable to the Department of State for the two years that have not been paid. We respectfully request the reinstatement fee be waived.
