ARTICLES OF INCORPORATION

OF

The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

ARTICLE II

This corporation shall commence its perpetual existence upon the filing of these Articles of Incorporation with the Department of State, State of Florida.
