**ARTICLE I**

The name of the corporation is: **GOTV, INC.**

**ARTICLE II**

The period of its duration is perpetual.

**ARTICLE III**

The purposes for which the corporation is organized is the transaction of any or all lawful business for which corporation may be incorporated under the Florida Corporation Act.

- A. To direct, supervise, participate in and support voters education in the State of Florida and throughout the United States.
- B. To plan details and perform activities and services which are supportive of cultural, social and political progress in the voters education and related fields, whether such details, activities and services economic or not.
- C. To actively support and encourage at all levels participation in voters education by qualified citizens and to assist said participation in an appropriate manner.
- D. To provide procedures and mechanisms for the full utilization of opportunities and advancement for the advancement of members in the voters education field, whether at home, in foreign states or abroad.
- E. To organize and associate with any groups, corporations, person, fraternities, sororities, societies or entities which have or may not have similar goals and objectives.
- F. To identify with, encourage recognition of and participation in voters education by registered and non-registered American and other groups which have historically been socially, economically and culturally disadvantaged to further promulgate the principles of American democracy by relating such activity in its

- G. To be a unique corporation which has effectively advance minority political participation.
- H. To receive financial support from foundations, corporations, religion institutions, unions, individuals, political groups, organizations and a broad section of the United State citizens who believes that America can and should be come truly interracial democracy
- I. To be a nonpartisan corporation which fosters minority and majority participation at all levels in order to build a more democratic, responsive, and representative system of government.

- P. To venture into join projects with individual(s) or group(s).
- Q. To provide travel services to individual(s) or group(s).
- R. To provide public and private information through research to individual(s) or group(s).
- S. To Lobby for public and private individual(s) or group(s).
- T. To venture into import-export joint projects.
- U. To venture into joint projects dealing with the electronic media.

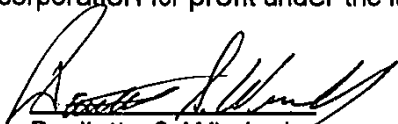

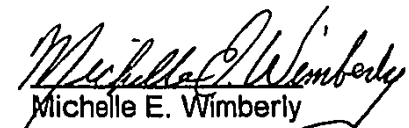

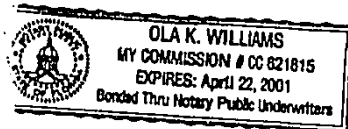
