The corporation is authorized to issue 10,000 shares of Common Stock having a par value of \$.10 per share.

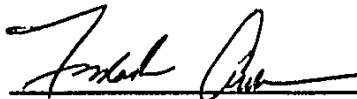
**ARTICLE III

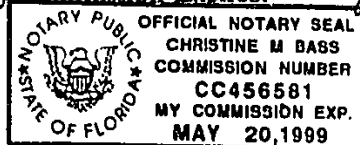
