#### ARTICLES OF INCORPORATION

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

## ARTICLE I

#### Name

The name of the Corporation shall be The Center For Dance & Theatre Arts, Inc.

#### ARTICLE II

# Principal Office

The principal office of the Corporation is located at 11 Lake Gatlin Road, Orlando, Florida 32806, and its mailing address is the same.

#### ARTICLE III

# Corporate Purposes, Power and Rights
