The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act hereby files the following Articles of Incorporation pursuant to Section 607.0202 of the Florida Statutes:

**ARTICLE I  
NAME**

The name of the Corporation shall be **GLEN and HOMA AUTO REPAIR, INC.** approved by the board of directors. The principal place of business shall be 2721 Forsyth Road, Suite 462, Winter Park, Florida 32792.

**ARTICLE II

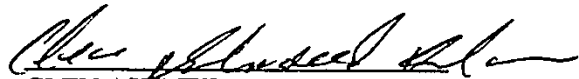
**ARTICLE VI

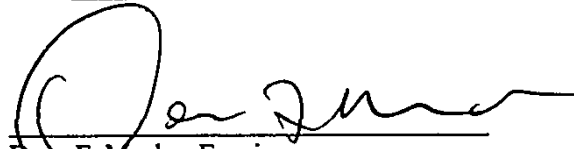
