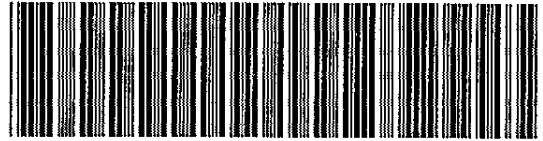

To engage in services and activities associated with the listing and sale of real estate, both commercial and residential, as a sales associate.

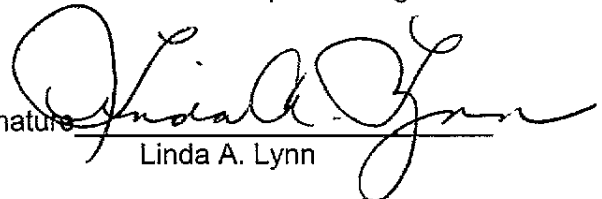
ARTICLE IV- NEW NAME

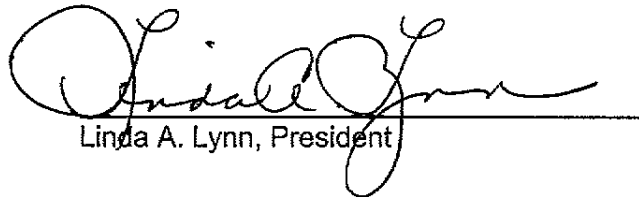
