ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is SPACE COAST MEDICAL CONSULTANTS, P.A.

ARTICLE II. DURATION

The period of duration of this corporation is perpetual.


ARTICLE VIII. INDEMNIFICATION


