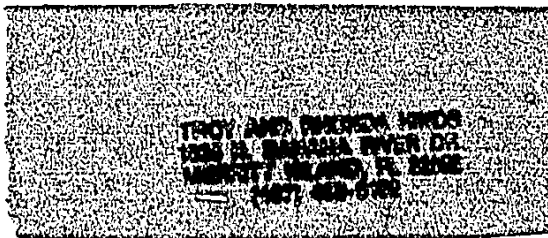

The undersigned incorporator, for the purpose of forming a professional corporation under the Florida Professional Service Corporation Act, Chapter 621 Florida Statutes and the Florida Business Corporation Act, Chapter 607 Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME
