These Articles of Incorporation shall be effective upon acceptance by the Secretary of State.

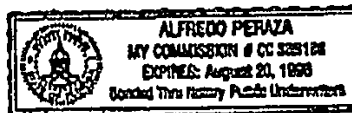
ARTICLE XI-AMENDMENT

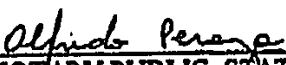
