**ARTICLE ONE**

The name of the corporation is SPECTRUM COST CONTAINMENT SYSTEMS, INC. The principal office of the corporation is 2112 Vance Avenue, Palm Harbor, Florida 34683.

The period of its duration is perpetual.

**ARTICLE THREE**

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.

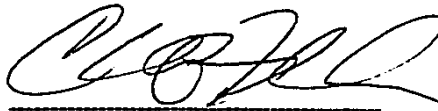

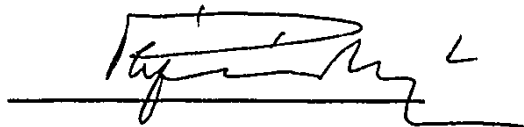
