**ARTICLES OF INCORPORATION  
OF  
Mui, Inc.**

THE undersigned, acting as incorporator of Mui, Inc. under the Florida Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is: Mui, Inc.

**ARTICLE II. ADDRESS**

The mailing address of the corporation is: 6436 Perry Street, Hollywood, Florida 33024

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

**ARTICLE IV. PURPOSE**

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

**ARTICLE V. AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 7,500 shares of common stock having a par value of \$.01 per share.

**ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is 6436 Perry Street, Hollywood, Florida 33024 and the name of the corporations initial registered agent at that address is: John Mui.

**ARTICLE VII. INITIAL BOARD OF DIRECTORS**

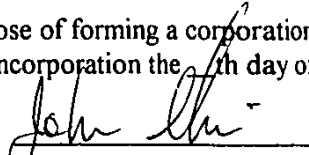
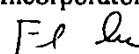
#### **ARTICLE IX. BYLAWS**
