

**ARTICLES OF INCORPORATION
OF
QUEST LAND DEVELOPMENT CORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME.

The name of the corporation is QUEST LAND DEVELOPMENT CORPORATION. The principal place of business is 8335 S.W. 132nd Street, Miami, Florida 33156.

ARTICLE II - DURATION.

The duration of the corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS.
