

OF

ARTICLE I
NAME

The name of this corporation is First Dartmouth Homes at Palm Bay, Inc.

This Corporation shall indemnify, defend, save and hold harmless and insure its officers and directors to the fullest extent permitted by law either now or hereafter.


ARTICLE IX

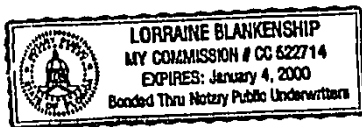
