**ARTICLE I  
NAME**

The name of this corporation is RENJES, INC.

**ARTICLE II  
NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is: any business authorized to be conducted by the laws of the State of Florida, including sales, operation of message therapy center.






