When I first recieved the (second) form for filing the Uniform Business Report I was taken back and instantly thought" I filed this, there has to be a mistake!"

Then it struck me. It was the same old problem I have been experiencing since 1997.

All of the below statements are easily verified and I will supply attachments to reinforce my plea.

- 1. On my postal route there have been several cases of mis-delivered mail, lost mail, checks missing; both incoming and outgoing and just plain incompetence on the part of the Oldsmar Post Office. This happens to me and my immediate neighbors on a basis that occurs in streaks.
- 2.I have asked for and recieved two Congressional Inquiries in the last 8 months to investigate my and others mail delivery problem. Both times the 9th District of Florida has looked into my problems and state that it was solved. Both times the issue was not, hence more than one inquiry.
- 3. I have contacted both the Oldsmar Post Office and the District Postal Inspectors to investigate.
- I believe they took the carrier off the route for a period of time and the problem stopped. He was reinstated by the Union and the problems started again. He is still on the route at this time.
- 4. During the exact time of filing of the original Report I was trusting the mail system and the report was mailed on the 20th of March, just before I left on a trip to North Carolina.
- 5. Also during the months of March and April, my sales tax returns both ended up missing, they never arrived in Tallahassee. The checks were never cashed, as well as the March 20th check for 150 dollars for the Uniform Business Report. I had to pay a late fee and face the embarrassment of reading a Tax Action letter.
- 6. Sales tax return was mailed on the 19th of March, Business Report on the 20th. Neither arrived in Tallahassee. Second letter from the Honorable Michael Bilirakis was mailed to me on the 28th of March stating it wouldn't happen again. It did, it still does.
- 7. Since April all my mail is now sceened and marked at the Post Office before delivery. Two more times my mail has ended up on another street and I recieve mail not addressed to me.
- 8. I now have to take all of my outgoing mail to the Post Office to be sent out, on recommendation of the Postal Authorities, a big inconvienence.

Therefore I am asking for a little help in this matter. The 400 dollar fine is stiff and should not have happened, I have an accountant that watches over all of my obligations and she is on record of having me get it out on time.
