OF

The undersigned subscribers to these Article of Incorporation, natural persons competent to contract, subscribes to and form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

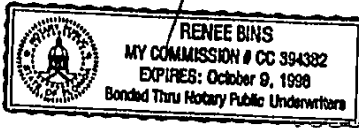
