ARTICLE I - NAME

The name of this corporation is AKM CORPORATION OF BROWARD

ARTICLE II - DURATION

This corporation shall exist perpetually unless sooner dissolved by law.

ARTICLE III - PURPOSE

The general nature of the business and the objects and purposes to be transacted and carried on are to collect and dispense information to various entities and persons including financial information, legislative information, news information, and information of any other nature and whatsoever; to act as a consultant information services; and to do any and all of the things herein mentioned as fully and to the same extent as natural persons might or could do; and to do any and all things and matters necessary and appertaining thereto, and further enabling this corporation to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue sixty (60) shares of common stock without par value.
