# Articles of Incorporation of Associates in Psychotherapy, Inc.

Article I - Name

The name of this Corporation is: ASSOCIATES IN PSYCHOTHERAPY, INC.

Article II - Principal Office and Mailing Address The principal office and mailing address of the Corporation shall be: 1559 San Remo Ave., Coral Gables, FL 33146

#### Article III - Duration

This Corporation shall have perpetual existence, commencing on the date of filing of these Articles.

#### Article IV - Purpose

This Corporation is organized for the purpose of engaging in the provision of services; in the import, export, purchase and sale of wholesale and retail goods and in any business permitted by law.

## Article V - Powers

The Corporation shall have all the Corporate Powers enumerated in the Florida General Corporations Act, Florida Statutes, Chapter 607, et. seq.

# Article VI - Capital Stock

This Corporation is authorized to issue three hundred shares of no par value common stock. Said stock shall be issued pursuant to a plan under §1244 of the Internal Revenue Code of 1954 as amended by the Small Business Tax Revision Act of 1958.

All of said Stock shall be payable in cash, services or property other than stock or securities in lieu of cash at a just valuation to be determined by the Board of Directors.

#### Article VII - Preemptive Rights

Every shareholder, upon the sale of any new stock of this Corporation of the same class or series as that which he already holds, shall have the right to his Pro-rata share thereof as nearly as may be done without the issuance of fractional shares at the price and under terms which said new shares are offered to others, said rights to be limited only as set forth in F.S. 607.0630.

## Article VIII - Rights of Shareholders

All Corporate powers shall be exercised by or under the authority of the Shareholders and the business and affairs of the Corporation may be managed by the Shareholders. Except as otherwise provided by law, the entire voting power for the selection of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

## Article IX - Initial Registered Office and Agent

#### Article XI - Bylaws

The Corporation may adopt Bylaws. The sole power to adopt, amend or repeal Bylaws shall be vested in the Shareholders.

This Corporation reserves the right to amend or repeal, in the manner provided by law, the provisions contained in these Articles or any Amendments thereto, and any rights conferred upon Shareholders is subject to this reservation.
