The undersigned, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I  
NAME OF CORPORATION**



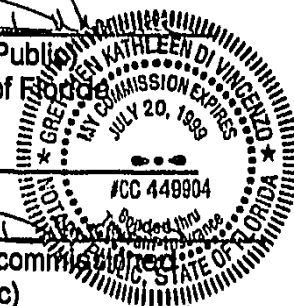


