#### ARTICLES OF INCORPORATION

OF

The undersigned, desiring to form a corporation for profit pursuant to the provisions of the corporate laws of the State of Florida, does hereby make, sign, acknowledge and file these Articles of Incorporation.

# ARTICLE I - NAME

The name of the proposed corporation is:

# ARTICLE II - PURPOSE

This corporation is specifically authorized and empowered to conduct business as follows:

- A. The specific business in which the corporation is primarily to engage is the operation of a business to provide housing to anyone.
