

ARTICLES OF INCORPORATION FOR ABCOMP CONSULTING, INC.



Pursuant to Chapter 607 of the Florida Statutes, the undersigned does hereby submit these Articles of Incorporation for the purpose of forming a profit corporation.

Article I - Name and Principal Office

The name of the corporation is ABCOMP CONSULTING, INC. The corporation's principal place of business address and its mailing address is 4210 NW 21 St., #119, Lauderhill, FL 33313.

Article II - Duration

The duration of the corporation is perpetual.

Article III - Purpose

The corporation shall engage in any activity or business permitted under the laws of the United States and of the laws of Florida.

Article V - Shares

The corporation has the authority to issue an aggregate one thousand common shares of capital stock at .01 par value.

Article VI - Commence of Business

The corporation will commence once the corporation has issued at least one common share in exchange for one thousand dollars in cash, property, or services rendered.

Article VII - Registered Agent and Registered Office

The name of the corporation's first registered agent is John J. Malerba, EA, and his address is 8551 W. Sunrise Blvd., #102, Plantation, FL 33322-4007.

As registered agent, I accept service of process for the above corporation at the place designated in these articles of incorporation. I accept this appointment and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties. I am familiar with and accept the obligations of registered agent for this corporation.

Article VIII - First Board of Directors

The name and address of the person who will service as director until the first annual directors and shareholders meeting, or until his successor is elected and qualified, is Ashton Bristol, 4210 NW 21 St.; 6 #119, Lauderhill, FL 33313.

Article IX - Powers of the Directors

The Board of Directors shall make, alter, or repeal the Bylaws of the corporation without restrictions of their powers conferred by statute.

Article X - Directors' Liability

A director of the corporation shall not be held liable to the corporation or its shareholders for monetary damages due to a breach of fiduciary duty, unless the breach is a result of self-dealing, intentional misconduct, or illegal actions.

Article XI - Name and Address of the Incorporator

John J. Malerba, EA, of 8551 W. Sunrise Blvd., #102, Plantation, FL 33322-4007, is the incorporator for the corporation.
