ARTICLES OF INCORPORATION

OF

JORGE E. RAVELO, M.D., P.A.

The undersigned Incorporator to these Articles of Incorporation, JORGE E. RAVELO, a natural person, competent and licensed to practice medicine in the State of Florida, acting hereby is hereby incorporating for the purpose of forming a professional service corporation for profit under the provisions of *Florida Statute Chapter 607*, *Florida General Act*, *Chapter 621*, *Florida Professional Corporation Act*, and does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this Professional Service Corporation is JORGE E. RAVELO, M.D., P.A.
