**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
MOLECULAR MEDIA, INC.**

MOLECULAR MEDIA, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby certifies as follows:

Pursuant to written action of the Shareholders and members of the Board of Directors of the Corporation, in lieu of holding a special meeting, the following resolution was unanimously adopted on July 11, 2012, amending the Articles of Incorporation:

RESOLVED, that Article III of the Articles of Incorporation filed with the Secretary of State of Florida be amended as hereinafter set forth:

"ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,800 shares of common stock having \$0.01 par value per share."

WHEREUPON, at St. Petersburg, Florida, this 12th day of July, 2012, the Corporation has caused its President to execute these Articles of Amendment to Articles of Incorporation, so that, on the filing hereof, the Articles of Incorporation shall be deemed amended accordingly.
