The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation: **EFFECTIVE DATE 7**
7-28-97

ARTICLE I

NAME OF CORPORATION

The name of the corporation is Sea Elf Marine Services, Inc. and the mailing address 100 Anchor Drive, Unit 478, Ocean Reef Club, Key Largo, Florida 33037.

ARTICLE II

COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date of subscription and acknowledgment of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are: To transact all lawful business for which the corporation may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

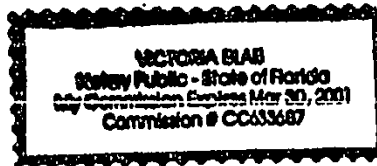
