The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be 550 AM BROADCASTING CORP.

ARTICLE II. PRINCIPAL OFFICE

The initial principal office of the corporation shall be located at, and the mailing address of the corporation shall be, 2070 North Palafox Street, Pensacola, Florida 32501.

ARTICLE III. TERM OF EXISTENCE

The corporation is to exist perpetually commencing on the date of execution of these Articles.

ARTICLE IV. CAPITAL STOCK

The corporation is authorized to issue 7500 shares of One Dollar (\$1.00) par value common stock.

The corporation shall initially have two directors. The number of directors may be increased or decreased from time to time by the bylaws, but shall never be less than one. ARTICLE VIII. AMENDMENT

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
