Pursuant to our telephone conversation this morning, I have assembled the documents that we discussed. As you may recall, last Thursday or Friday, I received notification from your office that my corporation (Robert E. Senton, P.A.) had been dissolved for failure to file the 2003 Uniform Business Report and pay the filing fee of \$150.00. Over the weekend, I was able to locate documentation showing that I had in fact submitted the report and fee in question. This documentation consists of a copy of the 2003 Uniform Business Report dated April 18, 2003, my corporate check, #5650, for \$150.00, and a copy of the front of the envelope that it was mailed in.
