**ARTICLE I**

The name of the corporation is COMMUNITY HEALTH ANALYSTS, INC. The principle office and mailing address is:

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

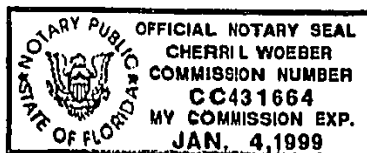

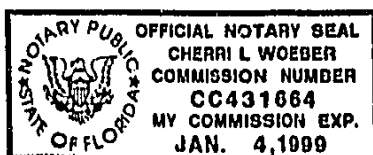
