**ARTICLES OF INCORPORATION**  
**RAMADAN WOUND CARE CENTERS, INC.**  
**A FLORIDA CORPORATION**

The undersigned, acting as incorporator of a Florida corporation, under the Florida General Corporation Act, Chapter 607 Florida Statutes, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I. NAME**

The name of the corporation is Ramadan Wound Care Centers, Inc.

**ARTICLE II. DURATION**

The corporation shall have perpetual existence.

**ARTICLE III. EXISTENCE**

The corporation's existence shall commence upon the execution of these Articles of Incorporation.

**ARTICLE IV. PURPOSE**

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated in the State of Florida.

**ARTICLE V. CAPITAL STOCK**

The corporation is authorized to issue one hundred (100) shares of all of one class of \$1.00 par value common stock.

**ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is 9303 N.W. 143rd Street, Alachua, Florida 32615, and the name of the registered agent of the corporation at that address is Rebecca G. Evans.

#### ARTICLE VII. INITIAL BOARD OF DIRECTORS

#### ARTICLE VIII. LIMITATIONS ON APPROVAL OF DIRECTORS


The shareholders of the corporation shall not be entitled to remove any director from office during his term without cause.


