ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FLORIDA AQUA FOODS, INC.

Pursuant to the provision of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- The name of the corporation is FLORIDA AQUA FOODS, INC. (the "Corporation").
- The following amendment of the Articles of Incorporation was agreed to and adopted by the sole director of the Corporation on December 30, 1998 and by the sole shareholder of the Corporation on December 30, 1998, in the manner prescribed by Section 607.1003 of the Florida Statutes:

ARTICLE IV of the Articles of Incorporation of the Corporation shall be amended to read as follows:

"ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000,000 shares of One and no/l00 dollar par value common stock, which shall be designated "Common Shares"."
