**ARTICLE I - NAME**

The name of this corporation is TOTAL BODY SOLUTIONS, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of filing these Articles of Incorporation with the Secretary of the State of Florida.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue ONE THOUSAND shares of \$1.00 par value common stock. There shall be no separate classes or series of stock of the corporation.

**ARTICLE V - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

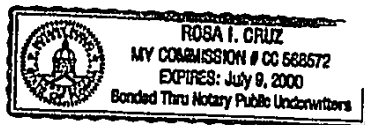

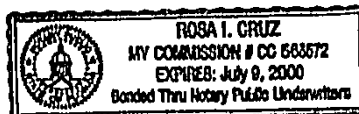

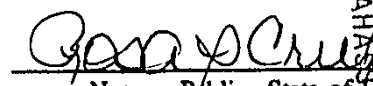
