ARTICLE IX - AMENDMENT

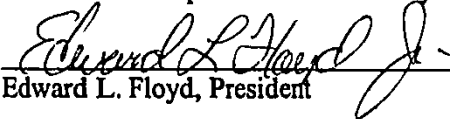

The date of commencement of corporate existence shall be August 15, 1997.

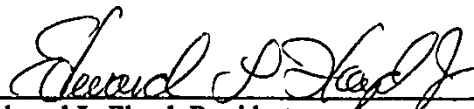
