## ARTICLES OF INCORPORATION OF ARMASIC, INC. 97 JUL 31 PH 1: 01

TĂTEAHASSEZ, FEORIDA

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopt the following Articles of Incorporation:

ARTICLE I Name 7-28-97.

The name of the corporation is ARMASIC, INC.

### ARTICLE II Duration
