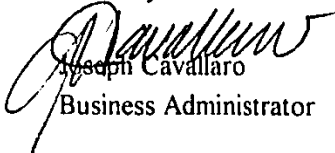

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Professional Association under the laws of the State of Florida.

**ARTICLE I - CORPORATE NAME**

The name of the corporation is Pavllon Aesthetic Center, P.A.

**ARTICLE II - DURATION**

The corporation shall exist perpetually unless dissolved according to Florida law.

**ARTICLE III - PURPOSE**

The corporation is organized for the purpose of engaging in the practice of Licensed Medicine and to transact any other lawful business to further the practice of medicine.

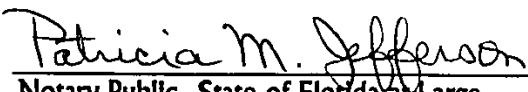
