**ARTICLES OF INCORPORATION  
OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the Laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be NATIVE SON BEACHWEAR CO.

**ARTICLE II**

This Corporation shall commence its existence on the 1st day of August, 1997, and shall exist perpetually unless dissolved in accordance with the Laws of the state of Florida.

**ARTICLE III**

The corporation may engage in any activities of business permitted under the Laws of the United States and of this State.

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1000 (ONE THOUSAND) shares of common stock at One Dollar (\$1.00) par value.
