Name and Address of Corporation

The name of this corporation shall be MARINA PROPERTIES, INC. The principal place of business and address is 1345 West Avenue, #904, Miami Beach, Florida, 33139.

Indemnification


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

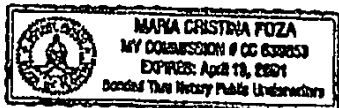
