Article I - Name

The name of this corporation is CAPITAL SOLUTIONS AND INVESTMENTS, INC.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business, brokering and placement of mortgages, or any other investment, lending, and financial matters and any other business related thereto.

Article IV - Capital Stock


