I.THE UNDERSIGNED, hereby submit to Incorporation under the record of the Ostrope of Florida, providing for the formation, liability, rights privileges and immunity of corporations for profit, the corporation named in Article I below.

#### ARTICLE I

The name of this Corporation shall be:
