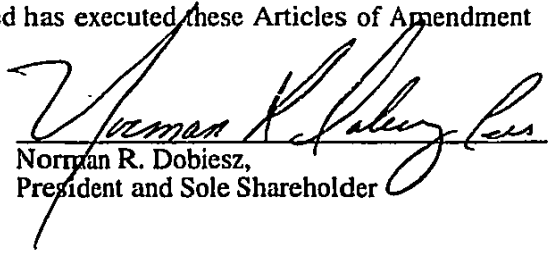
The undersigned, being the President and Sole Shareholder of FSS Development Corp., does hereby certify:

"The name of this Corporation is **International Development Corp.** and its principal office and mailing address is 13830 58th Street North, Suite 404, Clearwater, Florida 34620."

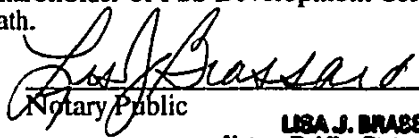
