ARTICLES OF INCORPORATION FOR PREFERRED REHABILITATION, INC.

Pursuant to Chapter 607 of the Florida Statutes, the undersigned does hereby submit these Articles of Incorporation to form a profit corporation.

Article I - Name

The name of the corporation is PREFERRED REHABILITATION, INC. 2962 Harbour Landing Way, Casselberry, Fl. 32707-5847

Article II - Duration

The duration of the corporation is perpetual.

Article III - Purpose

The corporation shall engage in any activity or business permitted under the laws of the United States and of the laws of Florida.

Article V - Shares

The corporation has the authority to issue an aggregate one thousand common shares of capital stock at .01 par value.

Article VI - Commence of Business
