The undersigned, in order to form a corporation for the purpose hereinafter stated, by and under the provisions of the statutes of the State of Florida, do hereby subscribe to these articles of Incorporation.

ARTICLE I - NAME

ARTICLE II - DURATION

This corporation shall have perpetual existence. The corporation existence commences at the date of the execution 31st day of JULY, 1997.

ARTICLE III - PURPOSE

This corporation is organized for the following purpose:

- a) Of transacting any or all business permitted under the laws of the United States of America and the laws of the State of Florida.

c) In the purchase or acquisition of property, business right of franchise, or for additional working capital, or for any other objective on or about its business affair and without limits as to amount, to incur debts and to raise, borrow and secure the payment of money in any lawful manner, including the issues and sale or other DISPOSITION of bonus, evidence of indebtedness, whether secured by mortgage pledge, deed of trust or otherwise. d) To engage in any or all lawful activity and to institute, participate in and promote and commercial, mercantile, financial and industrial enterprise and operations, and for the purpose of transacting any or all lawful business.


