ARTICLE I - NAME

The name of this corporation is RONELA OF OCALA, INC. The principal address of said corporation is 3716 NE 17th Street, Ocala, Florida 34470.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

- 4.1 This corporation is authorized to issue 7,500 shares of \$1.00 par value common stock.
