ARTICLES OF INCORPORATION

Of

BROZOVICH AGENCY, INC.

A Florida Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1

The name of the Corporation shall be: BROZOVICH AGENCY, INC.
