# **ARTICLES OF INCORPORATION**

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

# **ARTICLE I - NAME**

The name of the corporation is C&D BROKERS, INC., with a mailing address of 7350 SE 135th Street, Summerfield, Florida 34491.

# **ARTICLE II - COMMENCEMENT AND DURATION**

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

#### **ARTICLE III - PURPOSE**
